Dear Angel Foundation Supporter:

As I write this, I begin my third month as executive director for Angel Foundation.

During these first few weeks of my tenure, I have been truly humbled and inspired by the strength, energy and determination of the adults and families we serve.

In 2010, Angel Foundation helped more individuals and their families living with cancer than ever before. Our Facing Cancer Together programs supported hundreds of family members and adults with cancer. Through our Financial Assistance program, we distributed nearly \$520,000 in emergency financial assistance and Acts of Kindness and Caring to more than 1,000 adults with cancer.

Each day, more and more adults with cancer and their families turn to Angel Foundation for support. We are poised to expand and deliver programs that remain distinct in focus, but mutually beneficial and supportive of our families.

In 2010, we laid this groundwork through a strategic planning process resulting in a greater focus on development efforts and program enhancement and growth.

At the same time we look forward, we also celebrate a decade of hope, marking our tenth anniversary in 2011. Our theme this year is the Power of 10. Since our founding, we've seen how the efforts of working together can provide the impetus for growth. We know there is strength in numbers. Join us in this year-long campaign as we take the next step in our organizational development, moving beyond our first decade of providing help when cancer strikes.

Financial Assistance program

Cancer's impact:

- Forty percent of cancer patients report depleting their savings during treatment.
- Thirty to 50 percent fall below the poverty line.

Our impact:

- In December 2010, Angel Foundation surpassed the \$2 million milestone in distribution of emergency financial assistance to adults in treatment for their cancer.
- In 2010 alone we distributed nearly \$520,000 in emergency financial assistance and Acts of Kindness and Caring to more than 1,000 adults with cancer.



The top two reasons adults applied for financial assistance

- Couldn't work due to treatment
- High cost of care

Thirty-nine percent of financial assistance was used to pay mortgage or rent; 21 percent was used to buy food

Angel Foundation provides emergency financial assistance to adults in active cancer treatment for non-medical basic needs such as food, gas, utilities, and rent or mortgage payments.

Emergency assistance eases the financial burden and worry of program recipients, allowing them to reserve more energy for self care. In seeking and receiving these funds, financial assistance recipients gain a sense of control over their lives and are bolstered by the empathy and affirmation that their needs are recognized and met.

The year in review

Key initiatives:

2010 was a pivotal year for Angel Foundation as we prepared for future growth through:

- New leadership: appointment of Vicki Stute, our new executive director
- Strategic planning: development of a five-year plan
- Development/fundraising: hire of development officer for full-time focus
- Rebranding: adoption of a new organizational tagline and brand standards
- Endowment: introduction of Guardian Trust endowment fund

The Minnesota Charities Review Council's Standards of Accountability state that at least 70 percent of an organization's annual expenses should be for program activity with not more than 30 percent for management, general and fundraising expenses combined. In 2010,

Facing Cancer Together

Cancer's Impact:

- Each year, 23,000 Minnesotans are diagnosed with cancer.
- Nearly one in four adults who receives a cancer diagnosis is a parent of school-aged children living in the home.

Our impact:

Facing Cancer Together has helped 500 families facing a parental cancer diagnosis through education and support, since its inception in 2005.

In 2010, our Facing Cancer Together programs supported hundreds of family members and adults with cancer.

Through Facing Cancer Together, families with young children and teens living with a parental cancer diagnosis, receive accurate, ageappropriate information about cancer and its effects on the family. In a safe and optimistic environment, participants have the opportunity within their peer groups to ask questions, share their fears, access support systems and learn more about cancer. We firmly believe that a family can be strengthened through the cancer experience and take these learnings far into the future in order to thrive and face the profound uncertainties with renewed hope and meaning.

This program is the only one in Minnesota that works with the whole family when a parent is diagnosed with cancer regardless of the type of cancer or stage of the disease. Patients with nearly 90 different types of cancer diagnosis participated in our programs. We worked with families from a wide array of racial and ethnic backgrounds, family makeup and socio-economic status. Families come to us from all over the metro area and well beyond.

Facing Cancer Together offers activities throughout the year including:

- Education and Support Series
- Kids Kamp
- Parenting Through Cancer Support Group
- Teen Outreach
- Winter Retreat

In 2010, Angel Foundation developed a five-year strategic plan, providing a pathway for the organization's direction and

how it will reach its goals . The plan ensures that the most effective use is made of the organization's resources by focusing the resources on key priorities.

Throughout the organization's strategic planning process, key stakeholders actively participated in the development and refinement of the priorities, goals, and objectives set forth. Every staff member was involved in its creation and looks forward to its implementation through annual business planning and tactical execution.

The final plan is a rolling document in order to react to the ever-changing environments (internal and external), maximize recognized opportunities, and address potential threats. Finally, it provides a base from which progress can be measured and establishes a mechanism for informed change when needed.

Angel Foundation seeks to accomplish the following during the next strategic planning period:

Program. Expand program offerings in response to the needs of participant families.

Development. Build development infrastructure sufficient to sustain program needs, incorporating education and training of board and staff and adoption and implementation of a comprehensive development plan.

Administration. Develop operating environments, systems, processes, and controls to support both program offerings and institutional advancement.

Governance. I. Adopt a Policy Governance model that offers an evolution in board leadership and creates a successful governance-management relationship.

II. Ensure effective and knowledgeable board leadership.

III. With respect to best practice standards in nonprofit governance, appropriately define the role of the Founder to maximize the continued growth of the organization.
