IN 2025, ANGEL FOUNDATION SERVED 4,213 UNIQUE INDIVIDUALS THROUGH ITS COMPREHENSIVE PROGRAMS, PROVIDING RELIEF AND SUPPORT TO ADULT CANCER PATIENTS AND THEIR LOVED ONES THROUGH FINANCIAL ASSISTANCE, EDUCATION, AND EMOTIONAL SUPPORT SERVICES. A CORNERSTONE OF THIS WORK IS THE EMERGENCY FINANCIAL ASSISTANCE PROGRAM, WHICH HELPS INDIVIDUALS AND FAMILIES MEET ESSENTIAL NON-MEDICAL NEEDS SUCH AS FOOD, RENT OR MORTGAGE PAYMENTS, UTILITIES, TRANSPORTATION, AND OTHER HOUSEHOLD EXPENSES. THESE ONE-TIME GRANTS PROVIDE IMMEDIATE FINANCIAL RELIEF DURING A TIME OF SIGNIFICANT UNCERTAINTY AND STRESS, ALLOWING FAMILIES TO FOCUS ON TREATMENT AND RECOVERY RATHER THAN FINANCIAL HARDSHIP. IN 2025, ANGEL FOUNDATION PROVIDED EMERGENCY FINANCIAL ASSISTANCE TO 1,680 ADULTS FACING CANCER.

THROUGH PERSONALIZED SUPPORT AND PRACTICAL RESOURCES, THE PROGRAM AIMS TO INCREASE FINANCIAL CONFIDENCE, REDUCE STRESS, AND EMPOWER FAMILIES TO MAKE INFORMED FINANCIAL DECISIONS DURING A DIFFICULT TIME.

THROUGH INNOVATIVE, EVIDENCE-BASED PROGRAMMING, WE HELP INDIVIDUALS AND FAMILIES REDUCE FEAR AND ANXIETY RELATED TO THE CANCER EXPERIENCE, MANAGE STRESS, AND DEVELOP HEALTHY COPING SKILLS. OUR PROGRAMS ALSO FOSTER MEANINGFUL CONNECTIONS AMONG FAMILIES FACING SIMILAR CHALLENGES, HELPING PARTICIPANTS BUILD SUPPORTIVE COMMUNITIES WHILE HELPING THE PATIENT REALIZE THEY ARE NOT ALONE IN THEIR JOURNEY.
