GRANTS PROVIDE COMFORT AND PEACE OF MIND DURING THE OVERWHELMING MONTHS OF DIAGNOSIS AND TREATMENT. IN 2021, ANGEL FOUNDATION PROVIDED FINANCIAL ASSISTANCE TO 2,309 ADULTS RECEIVING TREATMENT IN THE ELEVEN-COUNTY METRO AREA (ANOKA, CARVER, CHISAGO, DAKOTA, HENNEPIN, ISANTI, RAMSEY, SCOTT, SHERBURNE, WASHINGTON, AND WRIGHT COUNTIES).
