Emily's Story

When Paul and Emily Lambrecht first learned that Paul had been diagnosed with Stage 3 rectal cancer, they were devastated. Both teachers, and he a beloved coach, they still had no idea how to talk to their three children (ages 4, 7 and 9) about Paul's diagnosis. Together, they managed to share the news and said they were hopeful the treatment would go well. Unfortunately, the family soon realized this was just the beginning of Paul's journey as his cancer continued to spread. "At first, we were confident we could do this on our own, but then the kids and I found ourselves worried and sad that we couldn't help Paul. We were overwhelmed," shared Emily.

That is when they found Angel Foundation. Paul and Emily were given an Angel brochure which included information about a camp for children. "I talked to the kids about Camp Angel and their initial response was, 'No way!' After thinking about it, though, my son told me he thought maybe they should go."

Once they got to camp, the kids found they felt completely at ease. Surrounded by caring staff, volunteers and other children who understood the struggles that come with a sick parent, they enjoyed just being kids and having fun. For Paul and Emily, watching their children live in the moment was a rewarding experience that changed their entire outlook.

"I felt such a connection with the other parents who were just trying to raise their children to be happy and confident in the face of family struggles. I laughed, I cried and I bonded with both survivors and other caregivers. Since we've been a part of Angel Foundation, our family realizes we are not alone and we know we are cared for. It's been a blessing that has helped us focus on what is important: our family, right now, being together."

That's why Angel Foundation offers financial assistance to local adults with cancer and supportive programs that help families take a breath and enjoy the little things.

Our Programs

Emergency Financial Assistance

Offering stability during a stressful time, Angel Foundation provides emergency financial assistance to adults living in or being treated in the seven-county Twin Cities metro area. Assistance is available for basic, non-medical living expenses such as housing payments, utilities, groceries and fuel.



Facing Cancer Together

Focusing on the entire family, Facing Cancer Together provides parents and caregivers the tools they need to parent through cancer. Talking to a child about cancer and how it will affect the family isn't easy, but it is necessary. Many parents are fearful their children will worry, so Angel offers kid-friendly programs to help get the conversation started. We also mix in a variety of fun social activities that give families the opportunity to spend time with others experiencing similar challenges.



Bearpath Golfs for a Cure

For many years, the generous Bearpath community has hosted a charity golf tournament named Bearpath Golfs for a Cure. This annual event is dedicated to helping women with breast cancer, and Angel Foundation was honored to be named beneficiary in 2017. Tammy Brooks, a member of the planning committee, recommended Angel Foundation because she and her fellow committee members wanted to ensure all funds raised would stay local and help women in their community. Held in July, Bearpath Golfs for a Cure included a continental breakfast, 9 holes of golf and a luncheon, complete with personal accounts from local breast cancer survivors. This beautiful event raised nearly \$13,000 to help Angel Foundation provide emergency financial assistance grants to 22 breast cancer patients in Eden Prairie and the surrounding area. We couldn't be more grateful!



Murder, Mystery and Matt Goldman

Retired oncology nurse Betsy Michel wanted a unique and fun way to raise money for Angel Foundation. When she learned her childhood friend Matt Goldman had recently published a murder mystery, the idea for "Murder, Mystery and Matt Goldman" was born. After asking Matt to perform a reading of his new novel, Betsy and her husband, Eduard, reserved a room in the Gale Mansion and invited friends and family to the

exclusive event. Guests were treated to dessert and coffee before listening to the author read a passage from his book, *Gone to Dust*, and discuss the writing process. Guests also received a free hardcover copy of the book, courtesy of Betsy and Eduard, which Matt was happy to sign at the end of the evening. This once-in-a-lifetime experience raised nearly \$3,500 for Angel Foundation and will not soon be forgotten by the event's guests.

Sisters Strong



Komen Race for the Cure® and created their own team, aptly named Sisters Strong.



Today, Sisters Strong has blossomed into a network of women who meet regularly to offer support and inspiration to each other. Every year during the holidays, Sisters Strong selects a mother who is undergoing treatment at Minnesota Oncology's Fridley or Coon Rapids clinics. Knowing cancer treatment creates financial challenges, Sisters Strong provides mom with food and gas cards to ease stress, plus gifts for her children to ensure they have a happy holiday. The Sisters Strong group also volunteers with organizations like Angel Foundation to help make sure other families have the support they need. From stuffing AngelPacks to volunteering at Camp Angel, these dedicated women embrace what it means to "live in the now." Their social and philanthropic activities help the members of Sisters Strong turn the challenge of cancer on its head, reminding themselves and others to celebrate the joy of everyday moments.

Lucas Kunde

Lucas Kunde lost his mother to cancer when he was just 15 years old. Now an adult, he has made a personal commitment to help children who are facing similar challenges. He was happy to discover Angel Foundation in 2015 and immediately joined the volunteer team. Over the last few years, Lucas feels his volunteer work has helped him focus on celebrating the important things in life.



"For me, it's important to live in the moment and enjoy the little things. Sure, I plan for the future - I've already started my daughter's college fund, for example - but, I also think what happens now is just as important. Spending time with family, celebrating birthdays or other milestones with friends and helping other people is my focus for today."

Since joining the Angel volunteer community, Lucas has assisted with several fundraising events, but his favorite task is working with kids and teens through the Camp Angel and Teen Outreach programs.

"Many of these kids simply want to try a fun activity they wouldn't normally get to do and it's great we can offer them new experiences. If they want to talk about the heavier things, like what is going on at home or school, I'm there for them. If they want to just enjoy our time together and have fun, I'm there for that, too. When it comes to the work I do with Angel Foundation, both aspects are equally important."

Tom & Tracy's Story

Thomas and Tracy Rheineck first heard of Angel Foundation through a former Angel Board member and they immediately connected with the mission. Growing up, Tracy learned firsthand how difficult it was to have a parent with cancer. Her father struggled with two different types of cancer and was ill for most of her childhood. Her family worried about finances throughout her father's illness and it often fell to Tracy to take care of her dad while her mother worked. Two months after she graduated from college, Tracy's father received a terminal diagnosis and passed away of esophageal cancer just 12 months later.

"I understand what these families are going through. It is hard and my heart weeps for them. Not only do they have to deal with the financial pressures it creates, they are also dealing with possibly losing their loved one. That's why Tom and I got involved with Angel Foundation. We love the mission and what it stands for. We are inspired by the wonderful work and great heart of the entire Angel team," Tracy said.

Lives We Touch *Mica's Story*

When single-mother Mica Anders was diagnosed with breast cancer in the fall of 2015, the news came as quite a shock. "It had already been such a bad day. I'd separated from my husband, my daughter and I were sleeping on the couch at a friend's house, I'd broken my ankle while moving our things and then, I got the call from my doctor. I just sat down and started laughing hysterically. It was either that or cry. I didn't know what to do," Mica shared.

Previously, Mica had tested positive for the BRCA gene mutation which put her at a greater risk for cancer, so she had already been receiving regular check-ups at the Mayo Clinic in Rochester. Deciding to continue her care with her current oncology team, she began traveling to Rochester for daily chemotherapy treatments. It wasn't long before the 160-mile round-trip began to take a toll on her finances.

"It was a hard time for Ruby and me. I was just beginning to establish myself as an art instructor in the local school system, so money was already tight. I really learned how to stretch a dollar, but it wasn't enough. That's when I started researching assistance programs and found Angel Foundation."

Mica immediately applied for financial assistance and was awarded an \$850 grant for fuel and other basic needs. She was also contacted by Angel staff and invited to Facing Cancer Together programs. They joined other families for the Winter Retreat and Ruby attended Camp Angel in 2017. They both appreciated the social aspects of Angel programs and it felt reassuring to be around others who were facing similar challenges.

"The grant we received relieved a lot of stress and the programs we attend help us focus on living in the moment. When we were invited to the Angel Gala, it was so great to be able to spend the evening dancing and laughing. That is something we don't often get to do with each other because I am either working or too tired from my long-term chemo side effects. It is wonderful to have those special times together. We are truly grateful."


